**Announcement No. 18 of 2025 of the General Administration of Customs and Ministry of Commerce to announce the decision to implement export control on some medium and heavy rare earth-related items**

In accordance with the relevant provisions of the Export Control Law of the People's Republic of China, the Foreign Trade Law of the People's Republic of China, the Customs Law of the People's Republic of China, and the Regulations of the People's Republic of China on Export Control of Dual-Use Items, in order to safeguard national security and interests and fulfill international obligations such as non-proliferation, it is decided, with the approval of The State Council, to impose export control on the following items:

(1) Samarium related items

(A) 1C902.a metal samarium, alloys containing samarium and related products:

1. Metal samarium (refer to customs commodity number: 2805301910).
2. Samarium alloys:
  - a. Samarium cobalt alloy;
  - b. Samarium ferroalloy;
  - c. Samarium nickel alloy;
  - d. Samarium aluminum alloy;
  - e. Samarium magnesium alloy.

3. Targets containing samarium (refer to Customs commodity No. : 3824999922, 8486909110) :

- a. Samarium targets;
- b. Samarium cobalt alloy target;

4. Samarium cobalt permanent magnet material.

3. 1C902.a.4, 1C904.a.4, 1C905.a.4 The permanent magnet materials controlled by item 3 include magnets or magnetic particles.

The export operator shall apply to the competent department of Commerce of The

State Council for permission to export the above items in accordance with the relevant provisions of the Export Control Law of the People's Republic of China and the Regulations of the People's Republic of China on the Export Control of Dual-Use Items.

Export operators should strengthen item identification, declaration should indicate in the remarks column whether it belongs to controlled items, which belong to controlled items should list dual-use items export control code. If there is any doubt about the above information, the Customs will question it according to law, and the export goods will not be released during the questioning period.

This announcement shall come into effect as of the date of promulgation. The Export Control List of dual-Use Items of the People's Republic of China shall be updated simultaneously.
